#### **DECLARATION AND SIGNATURE PAGE**

I am the owner of the qualifying trailer, have the legal authority to apply for incentive funding for the entity described in this application, and agree to the following statement by signing below:

- I (equipment owner or Principal of the above-named business) have reviewed the information provided in this application, including all supporting documentation, and certify the application information is true and correct, and that I meet the minimum requirements of the New York City Transport Refrigeration Unit (TRU) Incentive Program;
- I certify that the qualifying trailer is stationary and is not registered as an on-road vehicle;
- I understand that the replacement (new) TRU and trailer must remain stationary at the Hunts Point Produce Market.
- I understand that the program-funded TRU shall be placed into operation prior to the applicable operational deadline to remain eligible for funding. Approved applicants have up to 90 calendar days to complete installation of Replacement TRUs. Extensions may be granted on a caseby-case basis.
- To the best of my knowledge, neither the owner of the trailer(s) identified in this application nor the trailers have any outstanding violations or non-compliance with New York City or New York State regulations;
- I understand that incentive funds will only be used to offset the cost of the TRU purchase; applicable taxes are paid by the applicant.
- Any additional non-program funding needed to complete the purchase of equipment for the project according to the proposed timeframe is reasonably available;
- I understand that TRUs may not be purchased, received, or installed prior to approval by the TRU Incentive Program Administrator;
- I have all the information needed to understand what must be done to maintain eligibility for program funds. This includes retaining TRU ownership, keeping qualifying trailers in legal operating condition within New York, and maintaining TRUs in good condition;
- I understand that the program-funded TRUs are intended to remain in use on the qualified trailer for a minimum of three (3) years or until the completion of the Hunts Point Produce Market redevelopment;
- I understand that if approved by the TRU Incentive Program Administrator, visual inspections will be performed by a TRU Incentive Program
  Administrator prior to qualifying TRU removal to verify eligibility and after installation of the new TRU to verify compliance;
- I understand that an incomplete or illegible application, including applications that are missing required documentation, may be rejected by the NYC DOT or the TRU Incentive Program Administrator at their discretion;
- I understand that the program is being implemented at the discretion of the NYC DOT and any and all determinations are final and not subject
  to appeal;
- I understand that annual reporting is required for TRU Incentive Program funded units for a period of 3 years. Annual reporting may be collected via telematics and/or self-reporting. The information collected will include, but not be limited to: VIN, fuel consumption, hours of operation, TRU serial number, and domiciled address. TRU Incentive Program funded units may also be subject to an on-site inspection by a TRU Incentive Program Administrator. If an on-site inspection is requested, access to the TRU must be granted within a reasonable time;
- · Failure to comply with program use requirements will result in actions to recover program incentive funds; and
- I acknowledge that NYC DOT is subject to the Freedom of Information Act (FOIA) and may be required to release the information contained in the program application to third parties if required by State and Federal Public Record laws.

If the application was prepared by a third party, I certify that I have read the complete application after all forms and information were completed. I agree with the information provided, and the date provided below is the date I signed the form. Intentional falsification of these forms will be prosecuted to the extent allowed under the law and may be used as an adverse factor in future New York City incentive awards.
